1. Quotations are invited only from authorized Dealers of Exide with Buyback offer for existing 16 pc Exide battery, Type- EP-100-12.
2. Quoted items must be compatible with APC make online 6 KVA UPS, Model RC6000UXI.
3. Quotation should be submitted in sealed envelope superscripting "Quotations for Battery Bank" including rate, warranty and taxes as applicable.
4. Time schedule of delivery, acceptance test, installation are to be provided and strictly adhered to.
5. Price should be firm and exclusive of all taxes, duties and levies which will be paid extra as per rules.
6. Items with all accessories are to be delivered and installed at the Office of the Commission in the above address without any additional cost.
7. No advance payment will be made by the Commission. Payment will be made within 15 days after effective delivery, successful installation and testing of the Battery.
8. The original tax invoice must include PAN & VAT Registration Number and Service Tax Registration Number of the dealer.
9. Bank particulars are required to be submitted along with bills for making payment through NEFT/RTGS.
10. Validity period of the offer should be allowed at least 3 months.
