### NOTICE

West Bengal Electricity Regulatory Commission had issued Notice vide No. WBERC/B-18/2/2476 dated 28<sup>th</sup> March 2017 inviting applications from suitable persons for appointment/designating as Ombudsman but response to the aforesaid Notice being 'poor', WBERC hereby issues this **Notice** inviting applications from persons fulfilling the following criteria for appointment/designating as Ombudsman, WBERC as per the provision of 42(6) of The Electricity Act, 2003. The appointment will be initially for a period of 6 (six) months which may be further extended at the discretion of the Commission upto the age of 65 years. Intending candidates fulfilling the following qualification/experience criteria may apply to the The Secretary, WBERC, Poura Bhawan, FD-451A, Sector-III, Salt Lake, Kolkata-700106 latest by 5 PM of **19-05-2017**.

#### Essential criteria for the purpose of appointment.

1. Must be a person of ability, integrity and standing with a graduate degree in any subject and minimum experience of 25 years in public administration, especially in any Government Department/Regulatory Body/PSU holding the position not below the rank of Special Secretary/Additional Secretary to the Government / legal profession/technical profession as in engineering, finance, commerce, economics etc with similar position and experience as in public administration.
2. Age of the candidate for the position should not be less than 50 years but not more than 63 years as on 01-04-2017

#### Desirable Qualification

1. Degree in Law from any University of repute.
2. Sufficient exposure in dealing with legal matters in electricity industry/utilities.
3. Experience in hearing of public grievances and passing necessary reasoned orders.

Honorarium per month will be fixed as per existing norms of the Commission.
