		29.11.2016	<p style="text-align: center;"><b><u>ORDER</u></b></p> <p>1.0 The West Bengal Power Development Corporation Limited Ltd. (in short 'WBPDCL') and India Power Corporation Limited (in short 'IPCL') have sought extension of time for submission of the Multi Year Tariff (MYT) petitions for the fifth control period on the grounds stated in their respective applications.</p> <p>2.0 WBPDCL has mentioned that since different directives have been given by the Commission in the Tariff Order for 2016-17 issued on 28.10.2016 and many changes are applicable for the Power Stations of WBPDCL and impact of such changes are being worked out by them for which they require some more time.</p> <p>3.0 IPCL has also prayed for extension of time for submission of MYT petition for the fifth control period. In their submission IPCL has stated that some corrections/ revisions in the MYT order for the fourth control period are also pending for disposal before the Commission. These have impact in computation of revenue at existing tariff in the MYT petition for fifth control period.</p> <p>4.0 The Commission, after waiving all the procedural formalities and after giving due consideration to those submissions admits that there is some merit in their prayer relating to delay for filing the MYT petitions for the fifth</p>



			<p>control period. This consideration will, however, be applicable to all the tariff petitioners who may be either a licensee or a generating company.</p> <p>5.0 In view of stated facts above, the Commission in terms of regulation 8.3 of the Tariff Regulations decides to postpone the filing of tariff petitions for the fifth control period by the distribution and transmission licensees and the generating companies till further order.</p> <p>6.0 Copies of this order are to be given free of cost to all the distribution licensees, transmission licensee and also to the generating companies; tariff chargeable by them is to be determined by this Commission.</p> <p style="text-align: center;"><b>Sd/- (Amitava Biswas) Member</b></p> <p style="text-align: center;"><b>Sd/- (R.
